MESSERSCHMITT Bf110 BUILD (Part 2) Eraldo Pomare

The focus on the Bf110 build over the past month was on the nacelles, installing the motors, ESCs and framing the fuselage. The good news was that finding all the wires and pull-through strings in the wings went well so no surgery was required:)






The original Flair Bf110 model was powered by two brushed 600 motors wired in series to one ESC (electronic speed control).

Brushless DC motors each require their own ESC and in this case each ESC has a BEC (battery eliminator circuit to power the receiver and servos). Sometimes BECs from multiple ESCs can be plugged into the Rx without issue. Sometimes they can cause random glitches due to electrical noise or small stray currents, so even though the OS

technical representative at Tower Hobbies said I could plug both BECs into the Rx, I have decided to remove the +ve wire from one ESC so that only one BEC supplies power to the Rx. Only the -ve and signal wires are need to control the ESC from the Rx - the red wire supplies power to the Rx from the BEC.





The other decision was to wire the ESC power supply wires in parallel so that both ESCs see exactly the same voltage throughout the flight which should minimize any asymmetric thrust. The OS technical representative suggested running each ESC on a different (mixed) channel so that any differences in speed could be adjusted via throttle

curves. An excellent idea that I will adopt.

As designed, the model Bf 110 does not have rudders. I have planned to install rudders which means adding a servo, pushrod and bellcrank to operate the rudders. Hopefully the weight and hassle will be worth it. By the way, the model will have no landing gear - hand launch and *careful* grass landings only. No touch-and-goes.



WARNING: Technical Nerd Paragraphs below:

While deciding on the wiring configuration, I took the time to try to get a better understanding of how our brushless motors work.

Since I'm familiar with AC 3-phase motors in industry, I had assumed our brushless motors were pure AC but often wondered why our motors have magnets instead of a simple "squirrel cage" and also why a single ESC can't be used for more than one motor. Well the penny dropped, or more accurately, hit me between the eyes once I read a few articles: brushless motors are DC motors not AC motors at all; the ESC is not an inverter in the normally accepted sense - motor speed is a function of voltage rather than frequency.

The ESC is an electronic commutator which uses the back-EMF generated by the rotating rotor for timing instead of the familiar segmented copper cylinder and brush assembly of brushed DC motors. The two other functions/parts of the ESC are the variable voltage circuitry to modulate motor speed and of course the BEC discussed above. So Kv makes lots of sense too. Some brushless motors used in industry have sensors to more accurately time the electronic commutator, but as far as I know, all our model motors are sensorless. Anyone seen a sensor equipped model brushless motor?

This may not be news to many of you, but its amazing what happens when one stops to think. I should try that more often :)

- 6. MOST SAFETY ISSUES ARE SIMPLY COURTESY AND COMMON SENSE.

After considerable consideration and discussion, the committee reached a consensus on safety officer recommendations for approval by the club at a general meeting. Identifying the weakest link in past and present programs took the longest portion of time and the committee is comfortable with the outcome as listed in our recommendations. Under no circumstance did we desire to create new rules or restrictions in the club and agreed that education and currency was the real issue. Along side of this concept was the need to make the instructor program function better.

RECOMMENDATIONS:

- 1. ALL CARFF members are responsible for safety and as such must bring issues and questions to the CD (events), the executive, the participants, the member, or the general membership as is appropriate.
- 2. All Events, including fun fly's, demonstrations, and contests, must have a designated safety officer in attendance. The safety officer shall preside at a safety meeting with the participants, prior to any event flying and in the case of a 2nd day, provide a summary and any issues from the previous day, for the benefit of those in attendance and any newcomers on the 2nd day.
- 3. ALL INSTRUCTORS are required to attend a Safety Meeting each year to ensure currency and safety competency for the instructor. The Instructor is the only person in a position to ensure all members are aware of field rules and safety issues and as such must include safety and rules instruction during the wings process and thereafter as needed.
- 4. The executive will generate a current list of competent safety officers each year and post the list in the clubhouse. This list is to provide access to all members for any field rule or safety questions that may arise.
- 5. Current competent instructors as well as members at large will make up the list of safety officers.

This constitutes the entire recommendation of the committee. IF IT'S A SAFETY ISSUE, SPEAK UP!
